# **2 AREA OF RESPONSIBILITY**

The Aeronautical Information Service is responsible for the collection and dissemination of information for the entire territory of the Netherlands and for the airspace over the North Sea belonging to the Amsterdam FIR, including the delegated airspace up to and including FL 055.

## **3 AERONAUTICAL PUBLICATIONS**

AIS Netherlands operates in accordance with Commission Implementing Regulation (EU) 2017/373 requirements and publishes aeronautical information as aeronautical information products. These aeronautical information products consist of the following elements:

- a. The Aeronautical Information Publication (AIP) and amendment service (see paragraph 3.1 and 3.2);
- b. AIP Supplements (SUP) (see paragraph 3.3);
- c. Aeronautical Information Circulars Series A (AIC-A) (see paragraph 3.4.1);
- d. Aeronautical Information Circulars Series B (AIC-B) (see paragraph 3.4.2);
- e. NOTAM and pre-flight information bulletins (PIB)(see paragraph 3.5 and 3.6);
- f. Checklists and lists of valid NOTAM (see paragraph 3.7).

### 3.1 Aeronautical Information Publication

The Aeronautical Information Publication Netherlands is the basic document containing information of a permanent character as well as temporary information which is significant for the safe conduct of a flight. The AIP is available in English only.

#### 3.2 AIRAC amendments

For every AIP AIRAC amendment the AIS Netherlands website is updated. The ICAO AIRAC system is used to provide advance notice of the introduction of permanent operationally significant changes on an internationally recognised AIRAC effective date. In the AIP Netherlands an AIRAC amendment also contains non-AIRAC changes that are not operationally significant.

An AIRAC amendment does not replace the existing AIP until the AIRAC effective date on which the changes take place (see also paragraph 4).

In the HTML format, amendment changes are identified in the AMDT tab of the navigation pane on the left side of the screen. In the content pane on the right side of the screen, the changes are marked when the check box in the upper right corner of the content pane is selected. The changes are marked as follows:

- · inserted text has a light pink background;
- deleted text has a dark pink background and is struck through.

In the PDF format each page is dated to reflect the amendment's AIRAC effective date. A complete checklist of AIP pages, relating page reference to date, is reissued with each amendment in AIP section GEN 0.4. The AIP amendment cover sheet will indicate any changes that have been incorporated. On each replacement page, changes are either annotated or identified in the outer margin of the page by a thick black vertical line or horizontal arrow adjacent to the change/addition/deletion.

### 3.3 AIP Supplements

The information in an AIP Supplement is temporary (with a duration of 3 months or longer) or contains comprehensive text and/or graphics. AIP Supplements are published in English and will always be published according to the AIRAC system publication dates as defined in paragraph 4.

AIP Supplements are available for as long as all, or some, of their contents remain valid. They overrule the information published in the AIP during the indicated period.

### 3.4 Aeronautical Information Circular (AIC)

### 3.4.1 Aeronautical Information Circular Series A (AIC-A)

AIC-A contain aeronautical information, mainly of an administrative nature, which does not qualify for insertion in the AIP or NOTAM, such as:

- long-term forecast of any major change in legislation, regulations, procedures or facilities;
- · information of a purely explanatory or advisory nature liable to affect flight safety.

AIC-A are published in English.

## 3.4.2 Aeronautical Information Circular Series B (AIC-B)

AIC-B contain information or notification of an explanatory or advisory nature concerning technical, legislative or purely administrative matters. AIC-B are published in both English and Dutch.

### **3.5 NOTAM**

NOTAM will be issued when:

- a. the information is of a temporary nature (not exceeding 3 months); or
- b. permanent changes of operational significance, or temporary changes of long duration have to be published on short notice.

Whenever the changes contain extensive text or graphics, the information will be published as a supplement to the AIP. NOTAM are distributed via the AFS in the "System NOTAM" format.

#### 3.5.1 NOTAM service

NOTAM are distributed by telecommunications (AFS) only. NOTAM contain information about radio navigation aids, services, procedures and dangers in accordance with ICAO documents and EASA regulations. They are distributed by the International NOTAM Office in four series as follows:

### 3.5.1.1 NOTAM Series A

NOTAM Series A contain information of direct interest to international and national IFR/VFR flights en-route, or to and from international aerodromes within the Netherlands.

NOTAM Series A will be numbered successively from NR A0001 starting January 1<sup>st</sup> of each year.

#### 3.5.1.2 NOTAM Series B

NOTAM Series B contain information of direct interest to international and national IFR/VFR flights to and from aerodromes within the Netherlands.

NOTAM Series B will be distributed within the Netherlands and on request to other countries. They will be numbered successively from NR B0001 starting January 1<sup>st</sup> of each year.

Note: requests for incorporation in the distribution list of NOTAM series A/B should be addressed to EHAMYNYX by AFS.

### 3.5.1.3 NOTAM Series S

NOTAM Series S contain information concerning the presence or removal of hazardous conditions due to snow or ice on aerodrome pavements or standing water associated with these conditions.

Each NOTAM is assigned a serial number preceded by the letter "S" in case of a series S-NOTAM. This series starts every year at January 1<sup>st</sup> with number 0001. (For further information: see AD 1.2 paragraph 2).

### 3.5.1.4 NOTAM Series M

NOTAM Series M are disseminated by the military NOTAM Office (EHMCYNYX) and contain information of a temporary nature which is of direct interest to personnel concerned with flying operations within and below military airspace and of military aerodromes in the Amsterdam FIR and information of a permanent nature which is appropriate to the MIL AIP, but whose immediate dissemination is required. They will be numbered successively from NR M0001 starting January 1st of each year. Since these NOTAM contain information which is of direct interest to recipients of civil NOTAM Series A/B, NOTAM Series M are <u>automatically</u> disseminated to recipients of NOTAM series A/B.

Note: NOTAM series A/B and M are formatted based on ICAO documents and EASA regulations.

#### 3.7 Checklists and lists of valid NOTAM

For each element of the Aeronautical Information Package a checklist exists:

- with each published amendment a checklist of all AIP pages will be included.
- · twice a year a checklist with the valid AIC will be issued.
- every month a checklist of NOTAM in force will be distributed via the telecommunication network (AFS). These checklists (for each NOTAM series) also give the latest issued AIP amendment, AIP supplement and AIC.
- a monthly printed plain-language NOTAM summary is not AVBL.

# 3.8.1.2 VFR chart viewer

The VFR chart viewer (https://vfrchart.lvnl.nl/) is an interactive viewer for aeronautical data (AIP and other sources). It is updated according to the AIRAC cycles.

### 3.8.2 Homebriefing

Homebriefing offers pilots, aircraft operators and other aviation related organisations the possibility to file flight plans and associated messages and to request pre-flight information via the internet. Use Homebriefing via internet on https://www.homebriefing.nl.

Registration for use of Homebriefing is required.

## 3.8.2.1 Filing flight plans

Use Homebriefing to file VFR-, IFR- and Y/Z flight plans and check the status of a filed flight plan. The guidelines for submitting flight plans as stated in ENR 1.10 "Flight Planning" remain in effect.

## 3.8.2.2 Requesting pre-flight information

Use Homebriefing to request specific NOTAMs, SNOWTAMs and ASHTAMs as well as various PIB (see also paragraph 3.6).

### **4 AIRAC SYSTEM**

In order to control and regulate the flow of change implying amendments to charts, route manuals etc., whenever possible, such changes will be issued on predetermined dates according to the AIRAC system. If an AIRAC amendment can not be produced in time, a NOTAM clearly marked AIRAC will be issued.

The following table indicates the publication dates and AIRAC effective dates of the amendments to the AIP for the coming years.

Whenever major changes are being planned, and where additional notice is practicable, the publication date will be 70 days in advance of the AIRAC effective date.

At the publication date a Trigger NOTAM will be issued containing information about which AIRAC amendment or AIRAC supplement has been issued. When no AIRAC information has been issued "AIRAC NIL" will be published.
